NJFC ELECTION BALLOT FOR 2009-2010

The Board of Directors is proud to place into nomination the following members of Monmouth County Friends of Clearwater. **PLEASE NOTE: Write-in candidates can only be done at the Sunday, December 6th Elections. The candidate must be present and willing to serve on the board before the name can be approved as an addition to the ballot. No write-in names will be counted from absentee ballots.**

Absentee voters should only vote for the slate of up to 5 officers below. Place the ballot in a blank envelope and seal it. Then place the sealed ballot into another envelope and mail to: NJFC Elections, PO BOX 303, Red Bank, NJ 07701. If your membership renewal is due, please include that in the envelope with your ballot. To be counted, ballots must be at the post office by Saturday, December 5, 2009.

ON ELECTION DAY: Please vote for up to 5 nominees (this would include the 3 names placed in nomination by the Board of Directors AND any possible write-in candidates). VOTE CAREFULLY – A ballot with MORE than the maximum 5 will be disqualified. ALSO, if you decide to change a vote, make sure your change(s) very clear or the vote may incorrectly count your choices.
